Editor's Notebook

THE TIMES has again sought an update on the planned development of Rosedale Square from the Skinker-DeBaliviere Housing Corporation, learning that the housing corporation has apparently chosen a developer for Rosedale Square. A partnership of Saaman Corp. and Pete Rothschild has been negotiating with the housing corporation to purchase the 10 Rosedale Square buildings on Washington.

A Request for Proposals (RFP) was issued by the housing corporation in October, 2004, to convert the Rosedale Square Apartments into condominiums or townhouses. The housing corporation has owned the 68 unit complex (located at Rosedale and Washington) since 1988.

Saaman/Rothschild will no doubt wish to share their plan with the Neighborhood once it has been finalized with the housing corporation. Perhaps some of the perceived neighborhood needs, such as more housing designed for 'empty nesters', or possibly handicap-adaptable, will be considered in the final plans. THE TIMES has learned that the new partnership will be seeking historic tax credits for the project.

As reported previously, some residents feel this is a good opportunity to take advantage of the hot real estate market and convert the buildings from rentals to homeownership. Others are opposed to converting the property to condominiums or town homes, feeling that the loss of these rental units will take away from the affordability and diversity of the neighborhood. According to census data, over 300 rental units were lost during the 90s; since then, Washington University has absorbed at least 341 more, reducing the number from 1,519 to approximately 891, over 40.

One controversial issue is the use of sale proceeds from the sale of the building. The request for proposals indicated that the minimum bid should be \$2,500,000. After paying off the mortgages, net sale proceeds would still be considerable. To date, the housing corporation has made no public statement about the use of the excess from the sale of Rosedale Square. THE TIMES continues to request that information on behalf of the neighborhood. As a not-for-profit body, the housing corporation would be expected to use the proceeds of any such sale to further their housing goals on behalf of the neighborhood. However, no specific use for the funds has been announced.

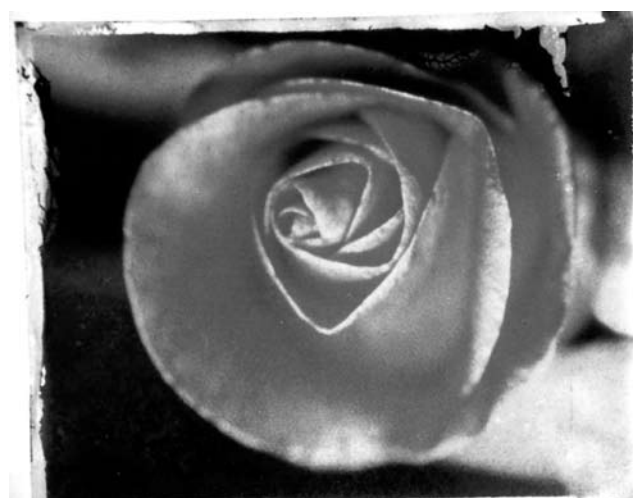

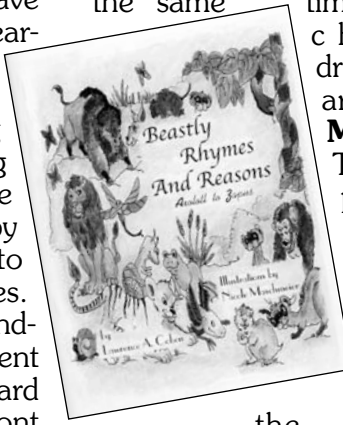

Ah, the 'Thai Stinker' cocktail at Thai Café!

Thai Café: Home of The Best Drink in Skinker DeBaliviere

It's not the lemon grass, coconut, or raspberry mojitos. It's not the Prickly Pear Margarita sipped casually while dining al fresco on a Spring evening. It's no caipirinha, and forget any drink over \$5.00. No, the best drink in Skinker DeBaliviere is the one I stumbled upon – the Stink – two years ago, when a friend from out of town, my husband, and I went together to the Thai Café to have dinner with another friend. Each of these two friends considers herself to be a person who instinctively orders the best thing on any menu. They are very competitive about it, and only really enjoy a meal if they are the person at the table with the best food and drink. I encourage this friendly competition, and order last.

I've always ordered the house wine at the Thai Café, because it is \$2.95. Sometimes a mistake is made, and they serve my house wine in a daiquiri glass, which is a lot of wine for \$2.95. My husband always orders Budweiser. For years, we had skipped entirely the cocktail menu, which includes such specialties as the Fog Cutter, the Scorpion, the Zombie, the Mai Tai, the Rum Keg, the Pina Cola, the Chee Chee, and finally the Thai Stinker. Importantly, we had missed the descriptions of these drinks – the Zombie, 'a real dirty stinker of dark rum and light rum;' the Fog Cutter, 'a potent vaseful of rum, gin, brandy, fruit juices;' and the Chee Chee, 'a fantastic drink of vodka served in a ceramic coconut.'

One friend was taken in by the prospect of the ceramic coconut, and immediately ordered the Chee Chee. The other friend read to the bottom of the menu, to 'a magical blend of rum, gin, cherry liquor, fruit juice and on fire,' and ordered the Thai Stinker. Being as it was 'and on fire,' it was sure to beat any drink served in a ceramic coconut.

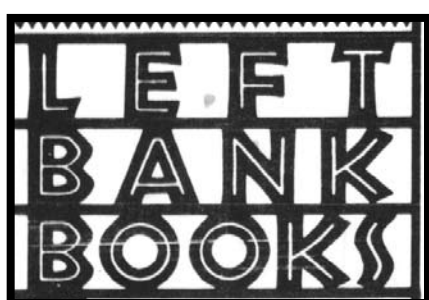
The Chee Chee was served first, and the ceramic coconut did not disappoint. It was kind of quaint and came with a paper umbrella, an orange slice, and a maraschino cherry. The drink itself, I do not remember.

Then the waiter went back to the kitchen to serve the Thai Stinker

separately, using both hands and carrying from underneath. He walked by several other tables gingerly balancing a large ceramic bowl, four inches deep and eleven inches wide, filled to the brim with the 'magical blend.' Hanging over the edges were four three-foot-long straws and two paper umbrellas. All eyes were on our table. The waiter set the bowl in the middle, between the four of us, and handed each a straw. Then he pulled a kitchen torch out from his waistband, poured a shot of alcohol into the interior ring of the bowl, and set it on fire. I believe there were cheers.

The bowl is what you sometimes see used as a chip and dip bowl, maybe at a Super Bowl Party, with the chips served in the outer ring, and the dips served in the inner ring. With the Thai Stinker, the outer ring of the bowl is used for the drink, and the inner ring is used for the fire. The inner ring rises up from the center of the bowl, sitting about an inch higher. Decorating the outside of the bowl are palm trees and half-naked hula dancers. The inner ring is painted red with lava, as if the flaming shot of vodka is actually a volcano spewing lava down into the drink.

At this point, it didn't matter what the Thai Stinker tasted like, because any drink served on fire in a bowl for \$4.95 must be the best drink in any neighborhood. It doesn't have to have green things floating in it, sugar or salt around the rim, and it doesn't have to age. Put it in a bowl, set it on fire, and charge less than \$5.00. That being said, the Thai Stinker is delicious. Nobody has yet to determine the exact recipe for this 'magical blend of rum, gin, cherry liquor, fruit juice and on fire,' and if you ask, the Thai Café will not tell. Even if you ask under the auspices of writing an article for the much heralded Skinker DeBaliviere Times, they won't tell. Again, it doesn't matter, because at \$4.95 you couldn't make it any better at home. Plus, what would you serve it in? The Thai Café is located at 6170 Delmar, across from the Pageant, and is now open seven days a week.

“Dinners on Delmar” Kicks Off June 17th

Residents of the Skinker-DeBaliviere community are well aware that one of the neighborhood’s top selling points is our excellent location, just steps from “The Loop” — one of the St. Louis region’s most vibrant and eclectic districts.

Now, thanks to a new social program, Skinker DeBaliviere denizens will have a ready excuse to take advantage of their close proximity to the many fantastic restaurants and watering holes located along Delmar in the Loop and East Loop neighborhood. “**Dinners on Delmar**,” which will celebrate its inaugural event on Friday, June 17th at the U Lounge at 609, will feature an outing to a different dining or drinking establishment along the Delmar strip every other month.

609, located at 609 Eastgate, just off of Delmar, is one of the Loop’s hippest new restaurants. Possibly an early instance of precast reinforced concrete, the design was inspired, I was told, by structures observed during the designer’s wedding trip in the Caribbean!

If MetroLink’s agreement with the Catlin Tract authority and/or the owners of Lindell residents in the subject block from DesPeres to DeBaliviere provided for replacing the wall with a replica, one would think that the two parties and the contractors as well would have a series of photographs pertinent to the disputed issue.

With a substantially different interest and purpose, I would be interested in hearing from anyone the Times may learn of who has photographs of the wall in any stage or state of its existence that might be suitable for an exhibition somewhere sometime.

WELCOME & INTRODUCTIONS - President Schesch opened meeting at 7:08 pm. Board members and guests introduced themselves. **MINUTES**: Motion was made and seconded to approve the minutes of the January 10, 2005 meeting. Motion passed.

FINANCE REPORT: A memo from Peggy Droege requested approval of the January and February financial reports. She had reviewed both reports and found everything to be in order. A motion was made and seconded to accept the Treasurer's Report. Motion passed.

We were also advised that receipt of funding from our institutional members and contributors was running behind and we would soon be sending out reminders. Board members were reminded to sign documents for CDA contract and there was discussion on establishing a fundraising committee.

WASHINGTON UNIVERSITY NORTH CAMPUS: Steve Hoffner, of Washington University discussed the University's plans for the Angelica Uniform property and the north campus area. Transporting, Housing, ROTC training center, mail services, TOP lawn care, security patrol, ACCESS program have been relocated to the north campus. In the next 3-5 years, approximately 500 employees will be housed at this location. The University plans call for the closure of Rosedale and the widening of Enright. The Radiant property will be demolished; landscaping will be added to create a more campus like environment. Long-term plans call for adding new student housing for graduate students and a recreation center. Two additional properties for the North campus could include the car wash and some City owned property. The University's presence provides a twofold benefit - it will help stabilize the area and provide patrons to support the local businesses.

At this time, Washington University is focusing on improving its current properties in lieu of acquiring new properties, working

with students to build a sense of community and getting involved in neighborhood activities.

Regarding the Delmar property, old Dobbs tire Center, Companion Baking will be moving in by the spring.

Washington University owns 9 properties on Pershing and will be doing new plantings. Additionally, parking improvements behind 4 buildings will be completed this year and by next summer the remaining 5 buildings will be completed.

SECURITY REPORT: Officer Metz provided the update. During February 1 - March 13, the following occurred

* 2 robberies, 9 autos stolen, 5 burglaries, 9 larcenies, 440 radio dispatched calls; purse snatching incident in the 6200 block of Pershing involving a 65 year old female; attacker had a vehicle waiting at Skinker & Pershing. A habitual car thief with 4 arrests is thought to be responsible for the car thief at DesPeres and Delmar.

* Major car repairs are taking place in the north alley - 5900 Waterman.

* Cars are parking at the end of the DesPeres in the circle making it difficult of cars to maneuver.

* Graffiti on DesPeres & Rosedale - request to let neighbors know what action one can take

* Residents were reminded to call 9-1-1 to report suspicious activity

Friends Campaign: Council needs to increase friends campaign. Looking for 1 - 2 council members to serve on Committee; will also solicit neighborhood residents. Liz, Andy & Norb will help. A suggested activity included 'A Taste of Skinker DeBaliviere.'

ALDERMANIC REPORT: No report. Alderwoman Krewson was out of town.

Executive Committee Report: Dan provided an update on Laure. She is in the hospital. Juanita keeps in touch with her on a daily basis.

METROLINK WALL - The wall put up is not the same as originally designed and presented. Only the side of the wall facing Catlin tract is designed. Dan received 50 responses (11 + 39) reflecting a 20% response to an email he sent out updating residents about the wall. Residents of Skinker DeBaliviere are concerned and do not find the wall as installed to be responsive to what they were originally presented. Motion made to write letter was seconded and approved with 1 abstention. Discussion followed. Some thoughts were to ask Metro to provide mitigation for what's there, at least make the

wall all the same color; demand Metro install any planting on North side of wall; also would create a sound barrier. Also request Metro to assume responsibility for maintenance.

2 people complained about bill board on condom ad promoting HIV/AIDS prevention awareness campaign. The billboard is not appropriate for neighborhood, especially the kids in the area and its proximity to a day care center

St. Vincent Greenway wants to create a walkway from Forest Park to Cool Valley. Dan and Alice will represent the Skinker-DeBaliviere. First meeting is being scheduled for later this month.

DeBaliviere West Condo Association: will meet every 2nd Tuesday at Council Office from 6:00 p.m. to 7:30 p.m.

Property Tax Assessment: Property assessments will be coming out soon and Skinker-DeBaliviere residents will see a significant increase. Homestead Applications were passed out. Dan will invite Assessor to next meeting. Dan will also contact Mary Bartley about joint meeting with CWE Association.

SLACCO CONFERENCE: Andy Cross attended and also was a presenter at workshop on Organization Effectiveness. Approximately 300 - 400 people attended. Andy reported that the conference was good and encouraged residents to attend next year.

EXECUTIVE DIRECTOR'S REPORT: No report, Laure is in hospital.

It doesn't seem that he's noticed you yet, and you can make out that he's thumbing through a copy of "Popular Mechanics."

You clear your throat and he looks up, simultaneously putting his magazine on the podium which you hadn't noticed before. Like the gates, it's made of television monitors – or are those pearls? You note that there's a name tag on his bathrobe. "Hello" it says in bright red letters; beneath that someone has written Pete. He smiles and you are a bit comforted. You almost feel as if he is going to ask you for your wish list of Christmas wants. Instead, he greets you by name and asks how you're doing. Odd, you think to yourself, his mouth never opened but he talked to me! You hear, "Moving mouths is inefficient. We don't need to do that here," and you again note

that his lips were still. "No, it's not a dream," he says before you even finish framing the question in your mind.

Anyway, you stand there a bit awed, reflecting on how quickly your life passed you by and wondering what's next. Suddenly a huge book appears on the podium. You gasp because your name is on the cover. It's a pretty thick book and you hope that this means something good. Pete says to you, "Yes, this is you, all 312 pages." You wonder if there are photos.
